Objective

To develop a research roadmap for PD&R, through engagement with HUD staff and the broader policy and research community, that defines a research program that leverages PD&R assets and informs decision makers and the public on critical housing and community development policy issues.

The roadmap will identify research priorities for PD&R and establish a set of research projects to undertake over the next 5 years.



PD&R Budget

Research & Technology (R&T) Fund

- \$46-48 million annually for the last three years
- \$52 million in HUD's FY 2013 request
- Focus on the nation's basic housing data infrastructure majority to AHS and other housing surveys

Transformation Initiative (TI) Fund

- HUD's new funding vehicle for large-scale research, evaluations, and program demonstrations "transformative" research
- Varied funding over the last three years totals over \$95 million for research and program demonstrations
- \$24-48 million in HUD's FY 2013 request
- 8 major research studies and demonstrations launched so far
